Investment strategy

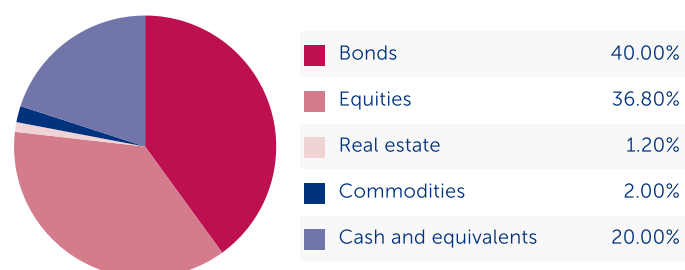

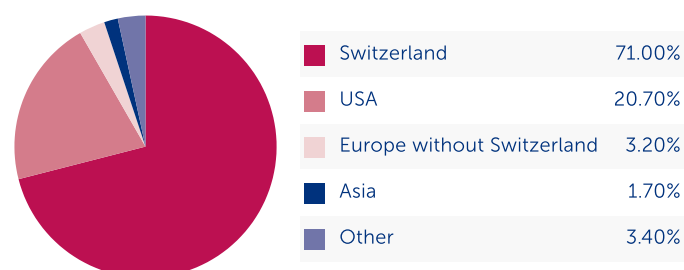

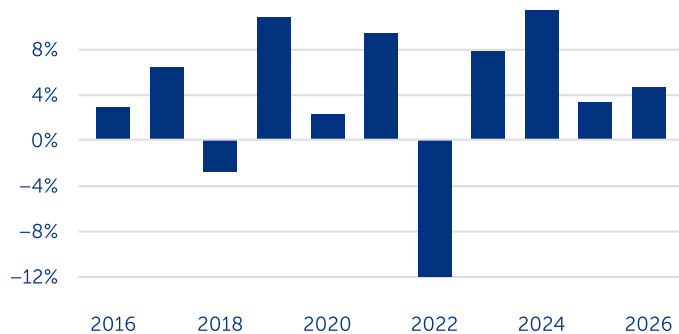
